## 12- POWER AND FUNCTIONS OF OFFICE BEARERS

- vii. To incur all expenditure necessary as in their own opinion useful for carrying out the objects and administration of the trust.
- viii. To appoint members of teaching staff, faculty, legal advisors engineers, architects, managers, accountants, clerks, agents nursing staff and other employees which may be required for the management of the trust on

- xv. To invest and deal with its funds and moneys in securities or property upon such terms and conditions and in such manner as may from time to time be determined or deemed expedient.

- or into whose hands and moneys or securities shall be deposited and other losses, unless the same has happened through their own negligence, default or omission, breach of Trust, misapplication or misconduct.
- 36- That Board of trustees may do acts to fulfill the objects of the trust not specifically written above.
- 37- That Trust may be dissolved at a special meeting of the Board of Trustees convened for the purpose with all Trustees present at such meeting.
- 38- That upon dissolution of the Trust, if there remains after the satisfaction of all its debts and liabilities any property whatsoever, the same shall not be paid to or distributed amongst the members of the Trust or any of them but shall be given or transferred to some other institution having objects wholly or in part similar to those of the Trust to be determined by the votes of two-third trustees present and voting specially called for the purpose or in default thereof by a Court of competent jurisdiction or can be transferred to the Government of on the undertaking that objects of the trust would be promoted and the established institutions would be maintained and the name of trust would not be changed under any circumstances.
